Please note that the CNWA, amongst other obligations, requires the owner to immediately notify the Minister if the work causes or is likely to cause serious and imminent danger to navigation, to take reasonable measures to mitigate potential dangers and to remedy any adverse effects that result from that danger to navigation.

This approval relates only to the interference of your work with navigation under the CNWA and does not grant any rights related to the ownership of the bed of the navigable water.

Please note that it is the owner's responsibility to comply with any other applicable laws and regulations.

As per the application (detailed above) to the Minister of Transport, submitted pursuant to the *Canadian Navigable Waters Act*, for an approval of the work per the attached plan(s), the Minister hereby approves the work pursuant to subsection 7(6) for the rebuilding of the above mentioned work, in accordance with the following terms and conditions:

- 1. All vessels navigating the waterway must be allowed access through or around the work site at all times during construction and must be assisted as necessary
- 2. All temporary works shall be completely removed when the work is completed
- 3. The temporary works shall have lights, from dusk to dawn and during periods of restricted visibility while in the waterway
- 4. Signs stating "Construction Ahead" must be placed and maintained 50 metres upstream and 50 metres downstream of the work during open water season
- 5. Signs shall be visible from 50 metres distance away
- 6. Signs shall display black lettering on an orange/yellow background
- 7. The Minister or his representatives must be allowed unimpeded access to any site related to the project for inspection and/or monitoring purposes.


